The proposed letter suggests the implementation of one part of the study before the other, meaning a capital, market and operational cost model to use for the study before analyzing the environmental, geotechnical, jurisdictional and engineering pieces. Mr. Provolt said it is important to remain objective and independent when conducting the study. All stakeholders have their opinion of what first to study. He also said the comparison of the East-West rail to the North-South line is not valid; the new railroad would be an extension of our deep-water port connecting the Pacific Rim through Humboldt Bay directly to the National rail system.

Debbie Provolt said a preliminary study will be less effective than the one being proposed by the East-West Rail advocates. She stated that a study to determine the best route should be done before the study to determine who will use the rail because you cannot look at who will use the rail until you know where the rail will be.

Captain Tim Petrusha, Bar Pilot, thanked the Board of Commissioners for considering a study of the rail. He said the industrial part of Humboldt Bay does not work well without the rail. The rail would open up opportunities for shippers.

Marion Brady, Eureka City Council, said Sun Valley Bulb Farm imports bulbs from Europe. They are shipped to Oakland and trucked to Humboldt County at a great cost. If there was an East-West rail that connected directly with the valley, Sun Valley would save hundreds of thousands of dollars. She asked that the feasibility study consider geology, bridges, finances, etc.

Richard Lentz, Land Bridge Alliance, thanked the Board for showing interest in the alternative rail feasibility study.

Commissioner Higgins stated it would cost billions of dollars to build the East-West rail. The chief major export will be coal. He said he believes misleading information is being promoted.

Commissioner Marks said the Harbor District is the only public agency that will come forward to do a feasibility study, to put the money towards a study. He said the public should not be upset about what the District will spend to do a study, but to be supportive of the District's efforts.

Commissioner Wilson said the letter is a good compromise. An alternative study cannot be done without going through the CEQA process. The North-South line is the District's reference point for the comments about the East-West rail.

Commissioner Dale said the District has always supported the rail efforts in this community. Everyone has the same general idea about the rail and there needs to be open discussion. He said it does not matter where the information comes from and at some point there is enough information to make the decision.

Commissioner Newman said this letter is necessary to express the Board's interest in this effort; it is a long road.

Commissioner Wilson suggested Commissioner Marks, as the Board's liaison, attend the Upstate Rail Connect meetings.

Pete Oringer said there is no information available yet to determine if the East-West rail is viable and he asked the Board to extend these feelings to any data-gathering efforts. He said the two rail lines, North-South and East-West, are like comparing apples to oranges. The East-West rail is a whole new venue/opportunity. We can learn from the positives and negatives of the North-South line. What happens with the Upstate Study has not bearing on the Harbor District. If the rail is important to the District, say that up front and support any date-gathering effort.

COMMISSIONER HIGGINS MOVED FOR THE APPROVAL OF RESOLUTION 2013-03, A RESOLUTION ESTABLISHING FEDERAL AND STATE LEGISLATIVE PRIORITIES FOR THE HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION DISTRICT DURING THE 2013 LEGISLATIVE SESSION.

It was decided by the Board to have a discussion of the legislative priorities with a resolution to follow at a future meeting.

The priorities from 2012 remain the Board's priorities, but they will be condensed for distribution by President Wilson and CEO in Washington DC.

COMMISSIONER HIGGINS WITHDREW HIS MOTION.

Commissioner Dale suggested adding sea level rise levee work, which will require federal and state assistance.

CEO will organize the priorities oriented to issues, not specific to federal, state or local assistance and will bring back to the Board for consideration on March 14.

President Wilson said last year there was a big push for additional dredging. He suggested the issue be included for 2013.

Director of Facility Maintenance

- Maintenance staff is getting ready for a busy season at Fields Landing Boat Yard.
- Took the recommendation of a Woodley Island Marina tenant and rekeyed the tenant restrooms so that there is one key for the mens' and one for the womens' in order to avoid confusion in the future.
- ❖ Built the first dock gate and installed it on F-dock.He feels the added security should work well for the tenants with the additional lighting and security cameras.

President Wilson stated establishing priorities is something the Board does every year before the Legislative Session; last year there were ten pages of items and not much response came from it, so CEO edited the document to create one-line sentences.

District Counsel reported these Priorities are also used for pre-approval when Staff deals with other agencies or when an issue needs an immediate letter of support and it cannot wait until the next meeting.

Karen Brooks reported she would like to see a few things changed about the Legislative Priorities: artificial reef changed to a mitigation project for the possible pulp mill purchase or other development projects; Samoa Industrial Waterfront Transportation Access Plan funding and working with CalTrans included; said railroad was too far down on the list if the Priorities are in order. Ms. Brooks stated East Coast is getting many modernization dollars due to the changes in the Panama Canal; asked what the distribution of funds of East Coast versus West Coast is; would like the District to work with the City of Eureka on dredging and options.

President Wilson the District has been working with the City of Eureka on dredging and will have to do more public outreach on options. President Wilson reported the Priorities are not in order. He said Priority #10 should end with "and access".

NEW BUSINESS

A. CONSIDERATION OF SCOPE REVISIONS AND REVISED CONTRACTS WITH PLANWEST PARTNERS, INC. AND LACO ASSOCIATES.

COMMISSIONER HIGGINS MOVED FOR APPROVAL OF SCOPE REVISIONS AND REVISED CONTRACTS WITH PLANWEST PARTNERS, INC. AND LACO ASSOCIATES. COMMISSIONER MARKS SECONDED.

George Williamson of Planwest Partners reported the Samoa Industrial Waterfront Transportation Access Plan has progressed significantly, especially due to LACO's efforts; said Kelly-O'Hern Associates is also involved researching easements and survey data.

President Wilson stated much of that information has been instrumental in negotiations regarding the possible Freshwater Tissue Company purchase.

Mr. Williamson reported LACO deserves credit for the work they have done, especially with CalTrans. Planwest Partners and LACO have agreed to scope and budget reductions to bring BST Associates into the project for a pre-feasibility rail study.

Mike Nelson, Vice-President of LACO Associates, stated so far the overall project is under budget and getting good support from the County, HCAOG and CalTrans.

President Wilson stated the current route protects the Timber Heritage Association lease area; the road is almost the least amount that can be laid and still touch all parcels that have waterfront access.

Commissioner Higgins reported he approves of the modifications and thinks everyone is well served.

MOTION CARRIED WITHOUT DISSENT.

B. CONSIDERATION OF ENTERING INTO CONTRACT WITH BST ASSOCIATES FOR FINANCIAL PRE-FEASIBILITY ANALYSIS OF RESTORING RAIL SERVICE TO THE SAMOA PENINSULA.

COMMISSIONER HIGGINS MOVED FOR APPROVAL OF ENTERING INTO CONTRACT WITH BST ASSOCIATES FOR FINANCIAL PRE-FEASIBILITY ANALYSIS OF RESTORING RAIL SERVICE TO THE SAMOA PENINSULA. COMMISSIONER DALE SECONDED.

CEO stated while there are many studies that have been done on North-South and East-West Rail, the information the District wanted was not available. He contacted BST Associates, a group he has worked with in the past.

George Williamson said the previous agenda item action allows for money through the Prop 1B grant to be available for this Item. He reported BST will develop estimates of cargo volume necessities and what types of cargo will make the Port more viable. Mr. Williamson said there is a final approval on the

use of the grant funds since Federal Highway Authority funds are involved. Once approved the Board will be able to fully consider this item.

COMMISSIONER WILSON SUGGESTED A FRIENDLY AMENDMENT TO APPROVE THE CONTRACT PENDING FINAL APPROVAL FROM FHWA. COMMISSIONERS HIGGINS AND DALE ACCEPTED THE FRIENDLY AMENDMENT.

President Wilson said the transportation plan in Samoa includes a rail component.

Commissioner Marks said the District needs additional information, the project is going in the right direction and he is looking forward to concrete numbers. Commissioner Marks stated NCRA has said publicly that the North-South railroad is not feasible; hewould like to see an East-West route given a chance.

Commissioner Dale stated this is the first step; is appreciative that LACO Associates and Planwest Partners worked out a sacrifice in this way.

Commissioner Newman said more information is a good thing.

Monte Provolt said publishing the agenda at the last minute did not allow time for the public to comment on this item. He stated many agencies have written letters of support for the East-West railroad. He believes this study is a duplication of the large-scale study on the horizon and is a waste of tax dollars.

Pete Oringer said between the tardiness of the publication of the Agenda and its supporting documents, and with this Item and the Legislative Priorities on the agenda, discussion should be put off until the next Meeting.

Debbie Provolt reported she is glad to see the Commission reviewing the East-West Rail possibility and believes there should be more public participation in the spending of \$20,000, which she believes would be better spent on a donation to the comprehensive East-West Rail Study.

Mike Newman, a member of RREDC and the UpState RailConnect Committee, in referring to a letter sent to the Board in response to their letter of February 14 to the Upstate RailConnect Committee said a feasibility study should come before a marketing study and asked the Board to put off their marketing study and work on a partnership with the City of Eureka. Mr. Newman stated the UpState RailConnect Committee believes a marketing study is premature at this point and encouraged the Board to put that money towards a larger East-West Feasibility study.

President Wilson asked if that decision was made by the Board of the UpState RailConnect Committee.

Mike Newman stated he was not sure since he was not in attendance at the last meeting, but believes it was talked about by the majority.

Karen Brooks said as a marketing person, one does not market anything until you have something to market; many ports are hubs for inland cities and thinks Humboldt Bay should see if any inland cities are interested in boosting the Port.

Marion Brady reported she read the letter from the UpState RailConnect Committee and thought it was good; stated a marketing study is making suppositions about things that may not be valid. Ms. Brady stated until there is something to market, you do not know what you can ship; said Upstate RailConnect Committee is opening dialogue

President Wilson reported this study is more of a financial pre-feasibility analysis instead of a marketing study; these funds cannot be given to another agency.

District Counsel stated this money has been awarded to study transportation issues in Humboldt Bay; if the District does not use it, they lose it.

Commissioner Marks stated there was a comment made earlier that none of this has been brought up, but it has been; he has talked publicly that he thought a study of this type is necessary.

Commissioner Newman said the District has to use these funds and considers this a valid way to do it; commerce is generated by transport. Commissioner Newman reported he is excited to see what comes from the study.

Commissioner Dale reported the information needed is not currently available, so the study is needed in order for the Board to make good decisions; will not hurt the feasibility study. Commissioner Dale stated the District will get good information that everyone can benefit from; thankful to LACO and PlanWest for making room in their budgets for this study. Commissioner Dale said he disagrees with Mike Newman about the financial analysis and feasibility study order.

Davey Young of McKinleyville stated he is concerned the District did not join the groups doing the feasibility study.

President Wilson said the Board was trying to figure out how to prioritize its participation.

Commissioner Marks asked CEO what the financial ramifications would be if the District were to put off making this decision.

CEO reported there is still time.

Commissioner Dale stated this will provide information he sees as valuable.

Commissioner Higgins reported it is to raise revenue and that the Marina is currently lower in its prices than others are.

Commissioner Wilson stated the Marina currently runs at a \$500,000 per year deficit, so District has been looking at other marinas to research their fiscal perspective.

Kevin Pinto said commercial charter boats should not be charged extra due to them bringing more people to the Island to do business.

David Helliwell reported he would like to know about other marina's profits or losses.

Commissioner Wilson stated while the Marina will likely always operate at a deficit, trying to get the figures closer to even is the goal.

Commissioner Marks said he does not believe marinas the same size as Woodley Island are being subsidized by the same amount and reiterated this Item is discussion only.

Kevin Pinto reported half a million dollars is not going to be recovered by charging four or five people extra, especially ones that bring business onto the Island.

Bill McBroome stated there is a lot of money spent in places people do not wish it to be spent, such as dock gates.

MOTION CARRIED WITHOUT DISSENT.

D. CONSIDERATION OF APPROACHES TO UPDATE THE CITY OF EUREKA GENERAL PLAN WITH REGARDS TO WOODLEY ISLAND.

CEO reported the options for additional uses of Woodley Island were stimulated from recent RV Park discussions; there are currently three choices: do nothing; a text amendment with a cost of about \$35,000 and a two or three year process; or through the City's General Plan Update with a cost of about \$20,000 and a three to five year process.

Commissioner Wilson stated he believes Option Three will be less expensive than \$20,000; asked Susan Penn about proposed text amendments regarding conditional uses of Woodley Island such as RV park, fuel dock, and direct sale of fish to the public. Commissioner Wilson reported in Option One the District is to do nothing and let the City take the lead; in Option Two, the District is the driving force;

in Option Three, the project goes to the City. Commissioner Wilson said what is decided tonight will direct Staff how to proceed regarding Woodley Island.

Ken Bates reported in Option One, the District presents the existing text and zoning to the City and lets them see if they want to change it; it would be the District advocating for public use of Woodley Island, such as it is now; in Option Two, there would be changes to the zoning and text on a parcel. Mr. Bates stated the District would put together a proposal, fill out and application and pay a fee; City staff would delegate tasks for the District to complete and the EIR would begin, which is expensive but allows faster progress if there are no problems; in Option Three, there is dialogue with the City Council and planning staff as they go through their General Plan Update, where anyone can input; District will spend far less money and the result will depend on the City.

Commissioner Wilson said Option Three has more public input and takes into account all other public planning; the District would still have to go through Option Two.

Bill McBroome reported he has brought up the idea of a J-dock, but he has never heard anyone speak of it; would bring in \$50,000 - \$70,000 more per year.

Kevin Pinto said this proposed project would bring a big change, which most people in the area are opposed to and he chooses Option One.

Troy Nicolini reported he likes Option Three: discontinue the idea of the RV Park but keep the ideas of the fuel dock and selling fish; has not heard anyone who thought the RV Park was a good idea.

Susan Penn said she is glad Option Three will not cost \$20,000 and chooses it even though she does not want the RV park; that way, the City can say whether it happens or not.

Rick Gustafson sent an email to the Commissioners and spoke with Commissioner Wilson today; likes Option Three.

David Helliwell reported he does not know why the RV Park is still being discussed; stated there was no support at the last meeting and now it turns up again.

Linda McMaster, Woodley Island Marina tenant, stated she votes for Option One.

Gary Mooslin, Woodley Island Marina tenant, said he votes for Option One and does not wish to have gates on the Island.

Vivian Helliwell, Woodley Island Marina tenant, reported she does not understand Options Two and Three and is not in favor of an RV park on Woodley Island; stated the District should use other of their properties to make money, but leans towards Option One.

Commissioner Higgins stated the District is looking at many options and making efforts to move forward economically; said some tenants consider an RV park to their benefit due to the District trying to utilize assets instead of just increasing slip fees to increase revenue.

Commissioner Marks said he leans towards Option Three.

Commissioner Wilson reported he has similar thoughts to Susan Penn; likes Option Three because the City is going to make the decision in the long run.

Commissioner Dale stated he likes Option Three due to public input; said the budget needs revenue development and this is just one of the ideas that is worth evaluating.

UNFINISHED BUSINESS

A. CONSIDERATION OF 2013 PERMIT FEES TO OPERATE A CHARTER SERVICE AT WOODLEY ISLAND MARINA.

CEO stated this is the third time this Item has been on the Agenda for discussion; asked other marinas what they charged charter boats. CEO recommended a \$500.00 annual fee.

Tim Klassen of Reel Steel Sportfishing made many points regarding the fee proposal: said Sonoma's average income is about 50 percent more than Humboldt County's and they have a longer fishing season; Charleston Marina has a longer fishing season and bigger charter boats that fit 20 or 25 people. Mr. Klassen stated he empathizes with the District's difficult financial decisions, but pointed out that \$500 per year is over 300 percent the current charge; reported the charter boat operators are trying to keep costs down to keep the boats as accessible to the public as possible. Mr. Klassen said if there must be an increase, \$250 seemed more feasible.

Monte Provolt stated his hope is that the Board will consider assisting small businesses such as the charter operators and not increasing their fees; they bring in business and it is a well-received service.

Gary Blasi of Full Throttle Sportfishing reported he agreed with Mr. Klassen; boats spend more in advertising due to the area not getting the tourist volumes other areas might.

Pete Oringer said Humboldt County is not the size of Los Angeles and the District's rates should not be based on an area that large; the charter boat operators bring other business to this area.

Matt Dallam of Northwind Charters stated with the economy being down, the charter boat operators must keep their fees as low as they can to generate revenue. Mr. Dallam reported they cannot afford to increase their rates, so an increase in fees means less income for them; many people that used to go to Alaska cannot do so at this time so they come here to fish. Mr. Dallam said the reason he is moored at Woodley Island is due to Trinidad harbor getting too expensive; commercial fishermen are making more than the charter boat operators. Mr. Dallam stated the charter boats bring business to the Ship Shop and the Café Marina; if they cannot make their rent, it will hurt the District financially.

COMMISSIONER MARKS MOVED TO INCREASE THE CHARTER BOAT FEES TO \$250.00 PER YEAR. COMMISSIONER HIGGINS SECONDED.

Commissioner Higgins asked about raising the rate to certain percentage of sales.

Commissioner Newman reported he agreed that fishing opportunities are more limited due to Humboldt County being within the Klamath Management Zone; considers \$250 to be a good compromise.

Bill McBroome, Woodley Island Marina tenant, said he thought incremental increases would be better for charter boat operators than big increases.

Commissioner Wilson asked how long the current fee had been the going rate.

CEO stated it had been \$25 for close to 20 years.

Commissioner Higgins reported if Halibut fishing were still open next year, it should bring in increased revenue for the charter boat operators; since the charter boat fee has not been raised in so long, recommends a higher rate.

PERSONAL SERVICES CONTRACT

THIS AGREEMENT, MADE THIS 12th DAY OF September, 2013 by and between the Humboldt Bay Harbor, Recreation and Conservation District, a California public entity, P.O. Box 1030 Eureka, CA 95502-1030 hereinafter called the "DISTRICT" and James Lund, hereinafter called "CONTRACTOR."

Consulting services will be provided by CONTRACTOR for pulp mill operations. By this agreement, CONTRACTOR and DISTRICT agree as follows:

TERM OF CONTRACT

CONTRACTOR is retained on a non-exclusive basis to render services commencing on Effective Date of Agreement. All work to be performed in accordance with this agreement shall be completed by the dates as set forth in Attachment A.

No work can be performed until the CONTRACTOR has received an executed copy of this Agreement.

INVOICES AND PAYMENT

DISTRICT will pay CONTRACTOR for the services hereunder a fee of \$60.00 per hour, on an "as needed" basis. The rate shall include Contractor's overhead for all necessary expenses in providing the work.

CONTRACTOR shall invoice DISTRICT on a monthly basis. Payment will be made to CONTRACTOR within 30 days of the invoice date for the approved invoice amount.

INDEPENDENT CONTRACTOR

It is understood that the services CONTRACTOR will perform hereunder will be in his professional capacity as an independent contractor; and that at no time shall CONTRACTOR be deemed an employee or agent of DISTRICT, nor shall he have the authority to obligate DISTRICT in any manner.

INDEMNIFICATION

CONTRACTOR shall be responsible for all injuries or deaths to persons and all damage to property of DISTRICT or others caused by or resulting from the negligence of CONTRACTOR during the progress of or connected with the services performed pursuant to this Agreement, and shall defend and hold harmless and indemnify DISTRICT and all its officers and employees of DISTRICT from all costs and payments for damages for injuries or deaths arising out of the negligence of CONTRACTOR if CONTRACTOR is otherwise a legal cause of the occurrence arising out of this Agreement.

CONTRACTOR AND DISTRICT shall defend and hold harmless and indemnify each other and all their officers and employees from all costs and payments for damages for injuries or deaths arising out of their respective negligence.

TAXES

CONTRACTOR assumes full and exclusive responsibility for the payment of all compensation and expenses of CONTRACTOR'S support staff employees, if any, and for all state and federal income tax, unemployment insurance, Social Security, disability insurance and other applicable withholdings, measured by the wages, salaries or other remuneration paid CONTRACTOR'S employees; and CONTRACTOR further agrees to comply with all rules and regulations applicable thereto.

PERFORMANCE AND ASSIGNMENT

The standard of care applicable to CONTRACTOR'S services will be the degree of skill and diligence normally employed by others performing the same or similar services.

CONTRACTOR shall not assign or subcontract any interest, obligation or duty in this Agreement without prior written approval of DISTRICT. This contract contemplates the unique skills and abilities of Contractor and may not be assigned.

INSURANCE

Consultant will file with the District before beginning professional services, certificates of insurance satisfactory to the District evidencing general liability coverage for bodily injury, personal injury and property damage; auto liability for bodily injury and property damage combined single limit; workers' compensation (statutory limits) and employer's liability (if applicable); requiring 30 days notice of cancellation to the District. Any insurance, self-insurance or other coverage maintained by the District shall not contribute to it. In the event that the Consultant employs other consultants (subconsultants) as part of the work covered by this agreement, it shall be the Consultant's responsibility to require and confirm that each sub-consultant meets the minimum insurance requirements specified above.

Any and all deductible amounts are the responsibility of the CONTRACTOR.

TERMINATION

DISTRICT shall have the right, at any time, in its sole discretion and with or without cause, by ten (10) days written notice to CONTRACTOR, to cancel this Agreement. CONTRACTOR shall stop work immediately upon receipt of a notice of termination and promptly deliver to DISTRICT the results of work to date of termination.

CONTRACTOR shall have the right, at any time, in its sole discretion and with or without cause, by thirty (30) days written notice to DISTRICT, to cancel this Agreement. Upon termination CONTRACTOR will promptly deliver to DISTRICT the results of work to date of termination.

In either event, upon termination of this Agreement, DISTRICT will reimburse CONTRACTOR within thirty (30) days for the services which were performed prior to termination, based upon an invoice submitted to DISTRICT describing the services completed prior to termination and an itemization of time spent and expenditures incurred. Such sums shall in no event exceed the total amount described in this Agreement.

EXTENT OF AGREEMENT AND SEVERABILITY

This Agreement represents the entire agreement between DISTRICT AND CONTRACTOR and supersedes all prior negotiations, representations or agreements, either written or oral. In the event any provision of this Agreement shall be determined to be void or unenforceable by any court of competent jurisdiction, then such determination shall not affect any other provision of this Agreement and all such other provisions shall remain in full force and effect.

This Agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.

This Permit and Agreement is executed in triplicate at Woodley Island Marina, Eureka, California, between HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION DISTRICT, hereinafter referred to as "District", and R. Charles (Doby) and Kim Class, dba *FIRST CLASS* hereinafter referred to as "R. Charles (Doby) and Kim Class."

WHEREAS, R. Charles (Doby) and Kim Class will be the Lessees of Slip Number 01, Float G, at the Woodley Island Marina for the sailing vessel OBSESSION, pursuant to a Berthing Permit and Rental Agreement for the Woodley Island Marina, a copy of which is attached hereto and incorporated by reference as Exhibit "A" hereto; and

WHEREAS, on or about August 08, 2012, R. Charles (Doby) and Kim Class made a written application to the District for a Permit from the District to operate the business *FIRST CLASS* on the sailing vessel *OBSESSION* moored at Slip Number 01 Float G at the Woodley Island Marina; and

WHEREAS, on or about August 14, 2013 R. Charles (Doby) and Kim Class made written application to renew the Permit to operate the business *FIRST CLASS* on a vessel moored at Slip Number 01, Float G at the Woodley Island Marina; and

WHEREAS, Ordinance Number 9, Section 6.78, subparagraph (a) of the District prohibits any commercial endeavor or charter service for hire without a special permit from the District.

AFTER REVIEW AND CONSIDERATION thereof by the Board of Commissioners of the District of the application of R. Charles (Doby) and Kim Class:

THE PARTIES, THEREFORE, AGREE AS FOLLOWS:

- 1. District shall permit R. Charles (Doby) and Kim Class, FIRST CLASS, to operate the business FIRST CLASS for the purpose of a Bed and Breakfast at the Woodley Island Marina. The Bed and Breakfast shall consist primarily of overnight accommodations and may include sailing excursions. Diving or diving instruction from or on said vessel shall not be allowed and shall be prohibited at all times at any locations within or without the boundaries of Woodley Island Marina while R. Charles (Doby) and Kim Class operates the business of a Bed and Breakfasts from the Woodley Island Marina.
- 2. The term of this Permit and Agreement shall be for one (1) year commencing October 01, 2013 and terminating on September 30, 2014. District or R. Charles (Doby) and Kim Class may terminate this Permit and Agreement by giving sixty (60) days written notice of termination to the other party. District may terminate this Permit and Agreement with R. Charles (Doby) and Kim Class with or without cause or reason by giving R. Charles (Doby) and Kim Class sixty (60) days written notice of termination and R. Charles (Doby) and Kim Class shall terminate their business, as defined in Paragraph 1, (60) days from the date of personal service of said written notice of termination or sixty (60) days from the date of deposit or the written notice of termination deposited, enclosed in a sealed envelope with postage thereon fully prepaid, in the United States mail, and addressed to R. Charles (Doby) and Kim Class, at 1578 10th Street, Arcata, CA 95521.

In the event **R. Charles (Doby) and Kim Class** are in default of any of the provisions of the Berthing Permit and Rental Agreement for the Woodley Island Marina, a copy of which is attached hereto as Exhibit "A", and **R. Charles (Doby) and Kim Class**'s Berthing Permit is terminated pursuant to said Agreement, this Permit and Agreement to operate a *Bed and Breakfast* shall terminate forthwith on the date of termination of **R. Charles (Doby) and Kim Class**'s Berthing Permit and Rental Agreement for the Woodley Island Marina without the requirement of the hereinabove set forth sixty (60) day notice of termination provisions.

- 3. In addition to the monthly rental payable by **R. Charles (Doby) Class and Kim Class** to the District pursuant to the Berthing Permit and Rental Agreement for the Woodley Island Marina, a copy of which is attached hereto as Exhibit "A", **R. Charles (Doby) and Kim Class** shall pay District the sum of Two hundred fifty dollars and no cents (\$250.00) per year, however all rates may be changed pursuant to paragraph 3 of the Berthing Permit and Rental Agreement for Woodley Island Marina which provides that the District may change or increase the rates by giving thirty (30) days notice.
- 4. On or prior to the date of the Agreement, to wit: October 01, 2013, R. Charles (Doby) and Kim Class shall purchase and maintain throughout the term of the Permit and Agreement Commercial General Liability insurance covering R. Charles (Doby) and Kim Class pursuant to the terms of this Permit and Agreement. Said insurance policy of "protection and indemnity insurance" insuring R. Charles (Doby) and Kim Class from liability for bodily injury, death, or property damage as a result of their operation and shall name District as an additional insured and provide District, prior to October 01 each year, with a Certificate of Insurance stating the amount of the insurance and proof that the District is an additional named insured, and the agreement of said insurance company that District shall be notified forthwith of the event of non-payment of the premium or termination of said insurance

policy. The amount of insurance shall be One Million Dollars and no cents (\$1,000,000.00) per occurrence. In the event said liability insurance policy referred to in the Paragraph 4 is cancelled or terminated, R. Charles (Doby) and Kim Class shall forthwith cease and stop their *FIRST CLASS* business at District's premises at the Woodley Island Marina and shall not resume operations until said liability insurance policy is fully reinstated and in full force and effect.

- 5. R. Charles (Doby) and Kim Class shall, prior to commencing operation of FIRST CLASS, obtain any and all necessary permits and licenses, if applicable, including but not limited to City of Eureka business license and United States Coast Guard vessel inspection. A United States Coast Guard inspection shall be conducted annually.
- 6. R. Charles (Doby) and Kim Class agrees that neither the Humboldt Bay Harbor, Recreation and Conservation District. Board of nor its Commissioners, nor any Officer of the District shall be liable to any extent for the injury or damages to any person or property or for the death of any person arising out of or connected with R. Charles (Doby) and Kim Class. and R. Charles (Doby) and Kim Class shall indemnify and hold harmless District, its Commissioners, and Officers free and harmless from any liability for any such injury, death or damages. In addition, R. Charles (Doby) and Kim Class agrees to hold harmless, indemnify, and hold District nonresponsible for any of R. Charles (Doby) and Kim Class's operations according to the provisions of paragraphs 11, 13, and 19 of the Berthing Permit and Rental Agreement for Woodley Island Marina, a copy of which is attached hereto as Exhibit "A" and incorporated by reference as though set forth in full.
- 7. **R. Charles (Doby) and Kim Class** at all times shall comply and shall obtain compliance of Lessees' family, agents, employees, business visitors, and invitees of all laws, ordinances, rules and regulations, including Ordinance

- No.9, the Woodley Island Marina Rules and Regulations, and those of local, state, and federal government.
- 8. R. Charles (Doby) and Kim Class at all times shall ensure that walkways and finger piers are not obstructed in any manner. No tires, ropes, canvas, or other material shall be nailed or attached to finger piers, docks, and piles without the written approval of the District. No person shall throw, discharge, or deposit from any vessel or from the shore or float or in any other manner, any waste, fish or shellfish parts into or upon the waters of the Woodley Island Marina or upon the banks, walls, sidewalks, or parking areas within the boundaries of the Woodley Island Marina. No person shall place or leave waste, dead animals, fish, shellfish, bait, or other putrefying matter on or along seawalls, harbor structures, floats, piers, sidewalks, or parking areas within the boundaries of the Woodley Island Marina. Vessel must be kept free of trash and waste product so as not to attract seagulls, sea lions, harbor seals, and other animals. All trash and waste product shall be properly disposed of each day.
- 9. R. Charles (Doby) and Kim Class may place a sign on the vessel the size of which must be approved by the District's Chief Executive Officer. R. Charles (Doby) and Kim Class may place a directional sign for incoming traffic onto Woodley Island Marina in an area approved by the Chief Executive Officer. Type and size of all signs are to be approved by the Chief Executive Officer of the District and, shall reasonably conform in size, shape, and colors of the signs heretofore existing on Woodley Island and the Woodley Island Marina.
- 10. This Permit and Agreement is not transferable or assignable by **R. Charles**(Doby) and Kim Class without approval in writing by the District. Any transfer of assignment or attempted transfer or assignment of this Permit by **R. Charles** (Doby) and Kim Class shall be null and void.

- 11. This Permit and Agreement is non-exclusive and District retains the right to enter into agreements with and grant permits to other persons or business for the same purposes as set forth in this Permit and Agreement.
- 12. The covenants and conditions herein contained shall apply to and bind the heirs, legal representatives, successors, and assigns of all of the parties hereto; and all of the parties hereto shall be jointly and severally liable hereunder.
- 13. Time is of the essence of this Permit and Agreement and of each and every covenant, term, and condition, and provision hereof.
- 14. R. Charles (Doby) and Kim Class is hereby notified by the District that this Permit and Agreement to Operate FIRST CLASS in conjunction with the Berthing Permit and Rental Agreement for a vessel at the Woodley Island Marina or property interests created herein, if any, may be subject to a possessory interest tax or property taxation if created pursuant to Sections 107 to 108 of the California Revenue and Taxation Code and that R. Charles (Doby) and Kim Class and/or the party in whom the possessory interest is vested may be subject to the payment of property taxes levied upon such interests. R. Charles (Doby) and Kim Class agrees and acknowledges that they have actual notice pursuant to Section 107.6 of the California Revenue and Taxation Code and that R. Charles (Doby) and Kim Class may be required to pay a possessory interest tax as a result of this Permit and Agreement to operate a Bed and Breakfast in conjunction with the Berthing Permit and Rental Agreement for the vessel for Woodley Island Marina. R. Charles (Doby) and Kim Class hereby acknowledge that they have actual knowledge of the existence of a possessory interest tax and have read the provision of Section 107 to 108 of the California Revenue and Taxation Code. R. Charles (Doby) and Kim Class agrees to and shall pay all possessory interest taxes levied by any governmental agency by reason

of this Permit and Agreement and their Berthing Permit and Rental Agreement for their vessel, for Woodley Island Marina.

Assessment of Cultured Shellfish Feeding Behavior and Water Column Characteristics to Inform Aquaculture Development in Humboldt Bay, California

Conceptual Proposal for the 2013 Saltonstall Kennedy Grant Opportunity

Aquaculture is an important part of Humboldt County's economy. In Humboldt Bay, Kumamoto oysters, Pacific oysters and Manila clams are currently cultured. The footprint of these shellfish culture activities totals approximately 300 acres and the industry supports approximately 60 jobs. As part of an overall effort to create jobs and improve local economic conditions, there are two public projects underway to expand local aquaculture activities. These projects involve 1) development of a marine research and innovation park that will include aquaculture, and 2) pre-permitting of new shellfish culture areas.

Marine Research and Innovation Park: The Humboldt Bay Harbor, Recreation and Conservation District (Harbor District) recently acquired a site on Humboldt Bay which is being converted from a non-operational pulp mill into a marine research and innovation park. Infrastructure at the site will be repurposed for aquaculture operations and it is envisioned that both commercial aquaculture and aquaculture research will be among the sites primary uses. Species cultured at the site may include shellfish, finfish and algae species as appropriate.

Humboldt Bay Mariculture Pre-Permitting Project: The Harbor District is currently prepermitting subtidal and intertidal sites in Humboldt Bay for expansion of current shellfish culture activities. Once sites are permitted, they will be leased to private shellfish growers.

Additionally, there are several private shellfish culture projects proposed in Humboldt Bay. These projects include sub-tidal shellfish culture, a remote shellfish setting facility and potentially a shellfish hatchery.

Questions have been raised by state and federal agencies, as well as local stakeholders, about Humboldt Bay's capacity to support growth in the aquaculture industry. Our proposed project will address this by assessing the following research questions:

- 1) Shellfish Feeding Behavior and Suspended Particulate Matter. What is the effect of different levels and types of shellfish culture on suspended particulate matter (food) in Humboldt Bay?
- **2) Water Quality.** Given variable water quality characteristics in different regions of Humboldt Bay, what types and levels of aquaculture will be sustainable?

Shellfish Feeding Behavior and Suspended Particulate Matter: Current and proposed aquaculture, particularly shellfish culture, has an effect on the abundance and composition of suspended particulate matter (food) available to all organisms in the bay. To assess the potential effects of current and proposed aquaculture, and provide information regarding Humboldt Bay's ecological carrying capacity, we will:

- 1) Examine the characteristics of particulate matter (e.g., % organic content) and how these characteristics affect bivalve clearance, absorption and growth rates in different regions of the bay.
- 2) Determine how the percent of particulate organic components correlates with chlorophyll concentrations in different regions of the bay and how both correlate with shellfish growth.
- 3) Quantify the feeding behavior of currently cultured shellfish species at potential aquaculture locations in Humboldt Bay over the course of one year to better understand their effect on the ecosystem.

This information will allow for a spatially explicit understanding of Humboldt Bay's capacity to support different types and levels of aquaculture.

Water Quality: Good water quality is important for all types of aquaculture. Additionally, aquaculture can have effects on water quality. To assess appropriate types and levels of aquaculture we need to understand existing water quality characteristics and how they would be effected by aquaculture. We propose to monitor water quality (temperature, salinity, pH, chlorophyll fluorescence, dissolved oxygen and turbidity) in different regions of the bay, including at existing and potential aquaculture sites. Additionally, water quality data from the existing CeNCOOS array will be incorporated into our analysis. A monitoring site located immediately adjacent to the marine research and innovation park will be particularly useful for identifying the species that could be cultured at that site and potential water quality effects of discharge from that site. The water quality information we will collect and evaluate is particularly important in light of the potential effects of ongoing ocean acidification on cultured species.

Overall, the project will allow for a comprehensive assessment of water column characteristics (suspended particulate matter, water quality) and shellfish feeding behavior that will provide new information regarding the potential environmental effects and sustainability of emerging aquaculture activities in Humboldt Bay. The information gained should also prove useful for aquaculture planning efforts in similar bays.
