President Hunter called the regular meeting of the Board of Commissioners to order at 7:03 p.m.

President Hunter announced there was no Closed Session prior to the regular meeting.

#### **CEO REPORT**

- Salmon Season: CEO reported 121 salmon season slip sign-ups were received; 40 cancelled due to weather, lack of fish, etc.; and the majority of the 81 left the marina before the end of the salmon season. On 9/10, the coordinating agencies held a "hot wash" to discuss the successful and unsuccessful preparations. The majority of the agencies felt that the agencies had done an adequate job of preparation as most participants had a good time and there were no major incidents in spite of the bad weather and the lack of fish. CEO reported the Harbor District netted approximately \$5,300 for the 10-day season.
- 9/9: Humboldt Bay Management Plan Advisory Committee meeting was held.
- A response was received to the June 1 letter sent to Mike Chrisman Secretary of California Natural Resource Agency regarding the MLPA process for the North Coast Study Region.

# Commissioner Pellegrini:

- Reported she has received complaints from marina tenants who own fiberglass boats. Tuna carcasses are being dumped in the marina and they adhere to fiberglass causing potential harm to the boats. CEO said he would look into the situation and report to the Board of Commissioners at the next meeting.
- Said there was a recent situation of a sea lion lunging at a person standing on one of the marina docks. CEO stated the sea lion was actually attracted to a garbage can containing tuna carcasses.
- Stated she had no luck halibut fishing, but the coho salmon were plentiful, even though they were "catch and release".
- Reported her husband's truck took first place in its class during the Cruisin' Eureka event this last weekend.
- Was happy to announce her oldest daughter is engaged to be married.

## Commissioner Higgins:

- Said from the comments he heard, the salmon season was well-received.
- Attended the Organic Planet Festival.
- Spoke with Bob Simpson, owner of the Freshwater Tissue Company. Mr. Simpson said CalPERS denied his request for funding, but that he is pursuing other options.
- Reported the candidates for Division 4 are promising, in his estimation. He thanked Commissioner Hunter for his many years of service to the Harbor District.

#### Commissioner Hunter:

Reported he missed the last Harbor District meeting because his wife was in the hospital. She has since had surgery and is on the mend.

#### Commissioner Wilson:

Stated at the last NCRA meeting, there was a review of NCRA's debts and schedule of payments. He said the Harbor District was low on the list. He asked CEO to investigate and report to the Board of Commissioners at the next meeting. District Counsel stated if there is no repayment in December 2009 by NCRA of the \$170,000 owed to the District, foreclosure would begin on NCRA's collateral.

Reported the Human Resources Advisory Committee will meet next week with the District's employee union representatives.

## Commissioner Pellegrini:

Said the response from Secretary Chrisman was disappointing to those people working diligently on the local MLPA North Coast Interest Work Group. He said Rick Starr of the Morro Bay SeaGrant will be invited to speak at an upcoming MLPA Interest Group meeting. Mr. Starr was successful in obtaining grant dollars for collaborative fisheries studies.
