## AMENDMENT TO ORDINANCE NO. 11

AMENDMENT TO ORDINANCE PROHIBITING VEHICLES,
INCLUDING MOTOR VEHICLES AND OFF-ROAD VEHICLES,
ON TIDELANDS, SUBMERGED LANDS AND FILLED LANDS OF
THE HUMBOLDT BAY HARBOR, RECREATION AND
CONSERVATION DISTRICT LOCATED WESTERLY AND NORTHERLY
OF AND ADJACENT TO BUHNE DRIVE, KING SALMON AREA,
HUMBOLDT COUNTY, CALIFORNIA

The Board of Commissioners of the Humboldt Bay Harbor, Recreation and Conservation District does hereby amend Ordinance No. 11, to include a prohibition of the overnight presence of persons on or upon any portion of the lands of the Humboldt Bay Harbor, Recreation and Conservation District, including the beach, tidelands, submerged lands and filled lands located westerly and northerly of and adjacent to Buhne Drive, King Salmon area, Humboldt County, California.

THE BOARD OF COMMISSIONERS OF THE HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:

- 1. No person shall operate, drive, possess, park or leave standing any vehicle, including but not limited to, two-wheel and four-wheel drive motor vehicles, automobiles, sand buggies, dune buggies, all-terrain vehicles, motorcycles, motor-driven cycles, motor-driven three-wheel cycles, motor-driven four-wheel cycles, motor scooters, trail bikes, minibikes and bicycles on or upon any portion of the lands of the Humboldt Bay Harbor, Recreation and Conservation District, including tidelands, submerged lands and filled lands, located westerly and northerly of and adjacent to Buhne Drive, King Salmon Area, Humboldt County, California, more particularly described in Exhibit "A" attached hereto and incorporated by reference as though set forth in full.
- No person shall be in, on, upon, reside on, remain on, park on, camp on, loiter on, trespass on or sleep on any portion of the lands of the Humboldt Bay Harbor, Recreation and Conservation District, including the beach, tidelands, submerged lands and filled lands located westerly and northerly and adjacent to Buhne Drive, King Salmon Area, Humboldt County, California, more particularly described in Exhibit "A" attached hereto and incorporated by reference as though set forth in full, overnight between the hours of 11 p.m. and 5 a.m. the following morning, Pacific Standard

Time, when Pacific Standard Time is in effect in Humboldt County, California, or overnight between the hours of 11 p.m. and 5 a.m. the following morning, Pacific Daylight Saving Time, when Pacific Daylight Saving time is in effect in Humboldt County, California.

- 3. Any person who violates this ordinance is guilty of a misdemeanor and upon conviction shall be punished by imprisonment in the County Jail not exceeding six (6) months or by fine not exceeding One Thousand Dollars (\$1,000.00), or by both fine and imprisonment.
- 4. This amendment to Ordinance No. 11 shall become effective thirty (30) days after the date of its publication in The Times Standard newspaper, Eureka, California, pursuant to the provisions of Section 22, Appendix 2, of the Harbors and Navigations Code of the State of California.
