Ordinance No. 6 Article III, Meetings is amended by adding to Article III, Meetings, Section 6.01 and 6.02 as follows:

Section 6.01. Time Limitations Agenda.

- 1. California Government Code Section 54954.3, subdivision (a) provides an opportunity for the public to address the Board of Commissioners of the District regarding any item of interest to the public appearing on the agenda and any item of interest to the public not appearing on the agenda at regular meetings of the Board of Commissioners of District that are within the subject matter jurisdiction of the Board of Commissioners.
- 2. California Government Code Section 54954.3 subdivision (b) provides the legislative body of a local agency may adopt reasonable regulations to ensure that the intent of Subdivision (a) is carried out, including but not limited to, regulations limiting the total amount of time allocated for public testimony on particular issues and for each individual speaker.
- A member of the public who desires to orally address the Board of 3. Commissioners of the District at a regular meeting of the Board of Commissioners of the District regarding any item appearing on the Agenda is limited to speak for a period of three minutes regarding each item appearing on the Agenda. A member of the public who desires to orally address the Board of Commissioners of the District at a regular meeting of the Board of Commissioners of the District is limited to speak for a period of three (3) minutes regarding items not appearing on the Agenda during the PUBLIC COMMENT portion of the Agenda. The three (3) minute time limit may not be transferred to other speakers. The three (3) minute time limit referred to in this paragraph 3 for each speaker may be extended by the President of the Board of Commissioners or the Presiding Member of the Board of Commissioners at regular meetings of the District. The three (3) minute time limit referred to in this paragraph 3 may be enforced by the President of the Board of Commissioners or the Presiding Member of the Board of Commissioners at regular meetings of the District.

Section 6.02. Time Limitations Agenda - Special Meetings.

1. The three minute time rule for public comment at a regular meeting of the Board of Commissioners of the District provided for in Ordinance No. 6, Article III, Meetings, Section 6.01, Time Limitations Agenda, applies to special meetings of the Board of Commissioners of the District.
