a) Receive Status Update Regarding the Humboldt Bay Offshore Wind Heavy Lift Marine Terminal Project

Recommendation: Receive the report and provide direction.

Summary: The Board has requested a monthly update regarding the Humboldt Bay Offshore Wind Heavy Lift Marine Terminal Project. Updates may include the project schedule, budget, funding opportunities, tasks completed, tasks underway, upcoming tasks, community engagement, and the latest overall project strategy. This report will provide an update for December 2024.

b) Receive a Report on the Design and Construction of a new Storm Water Treatment System for the Fields Landing Boat Yard

Recommendation: Staff recommends that the Board receive a report on the design and construction of a stormwater treatment system at the Fields Landing Boat Yard.

Summary: The Fields Landing Boat Yard regulated stormwater has been in exceedance for allowable volumes of certain metals, such as copper and zinc, resulting from the vessel repair and maintenance activities that occur on-site. This has made the installation of a new stormwater treatment system necessary. Under the authorization of the Board of Commissioners, SHN has completed a scope of work that included further assessing existing conditions, providing a basis of design, and preparing a complete project-ready plan.

Recommendation: Staff recommends that the Board: Adopt Harbor District Resolution No. 2024-13 which includes:

- Establishing Findings Relative to a CEQA Statutory Exemption and the Permit Application for the Wadulh Lagoon Tidal Wetland Enhancement Project
- Approving Permit 2024-02 with Conditions for the Wadulh Lagoon Tidal Wetland Enhancement Project

Summary: The Humboldt County Resource Conservation District's (HCRCD's) Wadulh Lagoon Tidal Wetland Enhancement Project (Project; Wadulh pronounced "wahdush") is intended to restore a diked former agricultural pasture to a combination of estuarine and palustrine wetland habitats, including salt marsh, brackish marsh, mudflat, and subtidal/intertidal eelgrass habitat, while protecting existing forested wetlands to the west. The Project will have long-term benefits for climate resiliency, coastal wetlands and associated native species, and sensitive species recovery and result in a mosaic of wetland types as well as a net increase in wetlands. The Project includes a 54-acre Project Area within a 78-acre parcel (APN 506-291-014) along the upper western portion of the Mad River Slough on Humboldt Bay, approximately 1.25 miles west of the City of Arcata, in Humboldt County, California (Figure 1. Project Site and Location Map). The Project Area is located on the Wadulh Unit of the Humboldt Bay National Wildlife Refuge (NWR) and the parcel is owned by the U.S. Fish and Wildlife Service (USFWS).

b) Consider Adopting a Tri-party Memorandum of Understanding with the California State Lands Commission and the Port of Long Beach to Coordinate and Collaborate Regarding Floating Offshore Wind Turbine Staging and Integration Port Facilities to Enable the Development of Floating Offshore Wind in California

Recommendation: Staff Recommends the Board adopt a Memorandum of Understanding with the State Lands Commission and the Port of Long Beach.

Summary: Staff from the Port of Humboldt (District) and the Port of Long Beach (POLB) collaborated on a tri-party Memorandum of Understanding (MOU) beginning in early 2024. Later in the year, both parties invited the California State Lands Commission (SLC) to join the MOU. Following multiple edits from each party, the final version is ready for Board consideration.
